 DRIVE4COPD: The DRIVE4COPD campaign is a landmark public health initiative of the COPD Foundation that aims to raise awareness of COPD, drive earlier diagnosis through risk screening, champion access to needed care and services, and advance efforts to help people with COPD live full and productive lives. Since the beginning of the campaign, DRIVE4COPD has screened more than 2.5 million Americans for COPD through its brief five question risk screener which has been disseminated online, at health and wellness fairs, medical conferences and at various sporting events and activities. Accomplishments have included the creation of an online COPD employer toolkit that provides organizations with the tools they need to develop and implement a successful COPD worksite program, collaboration with the National Business Coalition on Health to develop an action brief on COPD, recognition of the campaign as the official health initiative of NASCAR, utilization of celebrity Danica Patrick in media interviews to discuss COPD and various public policy and advocacy initiatives related to COPD.

 COPDGene Study: The COPDGene Study is a multi-institutional study of past and current smokers to identify the genetic factors that control the development and progression of COPD. The first five-year phase of the study created a cohort of over 10,000 smokers who are at risk for or express one of the various stages of COPD. A genome-wide association study was done on the entire cohort and pilot whole exome sequencing was carried out. Using imaging, clinical and genetic data, COPDGene will develop and validate a new classification system for COPD, which will dissect it into distinct pathophysiologic subtypes of this disease. Protein biomarker levels will be compared between COPD subtypes to identify biomarkers that associate with specific COPD subtypes.

 COPD Biomarkers Qualification Consortium: The Consortium's mission is to implement the qualification of public domain biomarkers that assist in the development and registration of treatments for COPD with the FDA. The current members of the Consortium are actively working with several academic centers, the NHLBI and the COPD Foundation to identify and publish key biomarkers. Letters of intent for three biomarkers were submitted to the FDA in March 2011.
