Background

For decades, supplemental oxygen therapy has been an essential treatment option for millions of people around the world living with breathing problems. From babies born with premature lungs to our eldest family members, people rely on oxygen therapy to reduce symptoms like breathlessness and activity limits brought on by chronic diseases like COPD and pulmonary hypertension. Others need oxygen therapy to help with more acute conditions like pneumonia and sleep problems.

Despite its ability to improve duration and quality of life, oxygen therapy has rarely been considered a priority for health care systems. Many people who could benefit from oxygen therapy are never diagnosed correctly. Some choose to forgo it because of the inconvenience, cost, or stigma. Still others never get the education they need to fully benefit from their oxygen equipment. The COVID-19 pandemic compounded the problem by increasing the demand for oxygen equipment and straining supply chains, issues that continue to this day. Evolving political and economic issues continue to challenge health care systems around the globe, and access to appropriate oxygen therapy is still a very real concern.

Our Purpose

Every person on Earth needs oxygen to survive. World Oxygen Day is here to help those whose bodies need extra oxygen thrive.









SOAR Act

The World Oxygen Day campaign supports health policy initiatives that improve access to appropriate supplemental oxygen therapy equipment. In 2024, the campaign focused on the Supplemental Oxygen Access Reform (SOAR) Act, legislation introduced in the United States. The SOAR Act focused on four key pillars of policy improvements:

1. Making oxygen therapy patient-centric

Modernizing terminology (like using "ambulatory oxygen" rather than "home oxygen" to reflect mobility improvements) and creating a "bill of rights for people who use oxygen" makes people the priority, rather than financial convenience.

2. Rationalizing reimbursement for oxygen equipment

Decades of well-intentioned but misguided policy decisions have slashed Medicare payments for oxygen equipment to the bone. Suppliers often cannot afford to provide optimal service to patients, and some forms of oxygen equipment (like liquid oxygen) have all but vanished. Appropriate payment levels should be set by the true costs of providing care rather than relying on the lowest bidder.

3. Providing access to respiratory therapy services

Respiratory therapists have unique skills and expertise that support oxygen therapy users. Unfortunately, these services have historically not been considered "medically necessary," so Medicare has not paid for them. Enabling access to respiratory therapists can help those prescribed oxygen therapy get the most benefit from their equipment and continue to live their best lives.

4. Establishing standardized documentation requirements

Historically, administrative requirements for prescribing oxygen therapy have been cumbersome and redundant. Recent efforts to reduce the paperwork burden have resulted in nebulous guidelines enforced by subjective reviews of medical records. Creating a clear, concise, and consistent national prescription template will reduce errors, improve care coordination, and protect against fraud, waste, and abuse.

The World Oxygen Day campaign proudly highlighted the efforts of more than two dozen patient advocacy organizations to promote the SOAR Act to the U.S. Congress, including days on Capitol Hill, call- and write-in campaigns, webinars, and other outreach.

The results are intended to guide health care leaders and national policy influencers in making evidence-based purchasing decisions, particularly in low-resource regions.


